3. Agency Spotlight - Perrenial!

Allison and Katie (ED) started in 2012 as an arts and sustainability nonprofit. "An artist on a bike" in the beginning. Mission is about resourcefulness. Jenny founded the organization on sustainable reuse of materials for use of art and expression. Woodworking, natural dyes, book binding, mosaic, home repair.

Since its beginning the program has expanded to partner with other organizations to work with formerly incarcerated and SUD clients. Works mostly with St. Louis locations. They are on the bus line. Looking to expand the coalition and alumni programs. No art skill necessary to participate in the program.

Program provides space Recreate Studio Classes on Sunday afternoons 1-4pm (3 Sundays per month) for workshops. Currently working with women who are making jewelry with the intention to sell it. Agency Spotlight - ARCA Housing - Tabled until another time

Jordan announced the RSS Cap changing from \$2,000 to \$6,000. Improved amount of time residents can be in housing. Marsha mentioned that the rate will be evaluated at the end of the quarter to see if they need to be adjusted. Third week of September the MCRSP board will determine if a change in the cap is needed. Participants who have been here since June will be included in the July 1st billing increase.

Marsha Hourd - Chair Updates/Funding updates

Marsha announced a new housing assistant at MCRSP to help Andy Thomas with NARR housing accreditations. Brendon will be "jumping right in" with regional site visits and conferences.

MCRSP gained a contract to provide NARR accreditation for Arkansas, Iowa, Kansas.

Training dollars need to be spent by September . First Annual Peer Summit on 10/24-25, 2024. Eastern Region can possibly pay for the registration fees for the Peer Summit

MCRSP Board will be having a full board retreat in September to review the MCRSP strategic plan.
